

OHIO CAMPAIGN FINANCE REPORTING CALENDAR 2024

See [Ohio Revised Code §3517.10](#) for complete details of the timing and requirements for most campaign finance reporting.

2023 Annual ¹	Jan. 31, 2024 to report activity through Dec. 31, 2023 .
Pre-Primary	March 7, 2024 to report activity through Feb. 28, 2024 .
Post-Primary	April 26, 2024 to report activity through April 19, 2024 .
Semiannual ²	July 31, 2024 to report activity through June 30, 2024 .
Pre-General	Oct. 24, 2024 to report activity through Oct. 16, 2024 .
Post-General	Dec. 13, 2024 to report activity through Dec. 6, 2024 .
2024 Annual	Jan. 31, 2025 to report activity through Dec. 31, 2024 .

This is based on the following **2024** election dates:

2024 Primary - March 19, 2024 | 2024 General - Nov. 5, 2024

Activity related to special elections may require reporting on different dates. Filing entities submitting reports to a county board of elections should contact the board for special election dates and filing deadlines not included on this calendar.

Additional Filing Requirements for Statewide Candidates Only – Monthly Reports

Monthly reports are required to be filed to report contributions received during the months of July, August, and September. These reports must be filed no later than three business days after the last day of the month covered by the statement.

July Report.....due no later than **August 5, 2024**.

August Report.....due no later than **September 4, 2024**.

September Report.....due no later than **October 3, 2024**.

Monthly reports are independent of any other report. The contributions listed in these reports are not repeated in any subsequent report.

¹ R.C. 3517.10(A)(3) The 2023 annual is not required of any filing entity for which a 2023 post-general is required.

² R.C. 3517.10(A)(3) Requires the semiannual to be filed by statewide and county candidates in non-election years and completely exempts all judicial candidates.



2024 Campaign Finance Calendar

- Jan. 19** Secretary of State and boards of elections must send notice to candidates required to file annual campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- Feb. 26** Secretary of State and boards of elections must send notice to candidates required to file pre-primary campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- April 16** Secretary of State and boards of elections must send notice to candidates required to file post-primary campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- July 19** Secretary of State and boards of elections must send notice to candidates required to file semiannual campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- Oct. 11** Secretary of State and boards of elections must send notice to candidates required to file pre-general campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- Dec. 3** Secretary of State and boards of elections must send notice to candidates required to file post-general campaign finance reports.....R.C. [3517.10](#), [3517.11](#)

2025 Campaign Finance Calendar

- Jan. 21** Secretary of State and boards of elections must send notice to candidates required to file annual campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
